

## ***Meece Middle School SBDM Parent Election***

The Meece Middle School PTA will hold an election for **ONE** parent member (2yr term) for the Meece Middle School (SBDM-Site Based Decision Making Council) School Council on **May 15<sup>th</sup>- 2017** at Meece Middle School. The time of the election: **The start of school until 3:30 pm.**

### INFORMATION ON SBDM SCHOOL COUNCILS

What is the school council? The council is the governing body for this school. It decides school policy for curriculum, staffing, discipline, scheduling, instructional practices, extra – curricular activities and other matters pertinent to the operation of the school. **The council meets monthly on Tuesdays at 3:30 PM in the Meece Middle School Library.**

Who serves on the council? 2 parents, 3 teachers, and the principal.

Who may run for council? Any parent, stepparent, foster parent or legal guardian of a student who will be attending the school during the parent’s term of office. A parent is ineligible if he/she is an employee or a relative of an employee of that school or the district the district central office, or a local school board member or the spouse of a school board member.

What are the terms of office? \***2 year, beginning June 2017 ending June 2019**

How will I know who is running for council? The slate of nominees will be put in teacher mailboxes to be sent home with students on **May 5<sup>th</sup>**. It will also be sent to PTA parent’s email addresses.

If I want to run for council, what do I do? Complete the attached nomination form and return it by **May 3<sup>rd</sup>**. You may nominate yourself or another parent, if you have that parent’s consent.

Who may vote in the election? Parents, step parents, foster parents, legal guardians of students attending school.

When do we vote? Voting will take place on **Monday, May 15<sup>th</sup>** at Meece Middle School from **the start of school until 3:30 pm.**

### Nomination Form SBDM Parent Council Member

Deadline: Must be returned to the Nomination committee or taken to the front office at Meece and given to office staff member by **Wednesday, May 3<sup>rd</sup>, 2017**

Qualifications: A parent council member shall be a parent, stepparent, foster parent or legal guardian of a student attending the school during the council member’s term of office. A parent is ineligible if he/she is an employee or a relative of an employee (father, mother, brother, sister, husband, wife, son daughter, aunt, uncle, son – in- law, daughter –in-law) of that school or for the district central office, or a local school board member or the spouse of a school board member.

**The Term of Office: Parent - 2-year term begins June 2017 ends June 2019**
